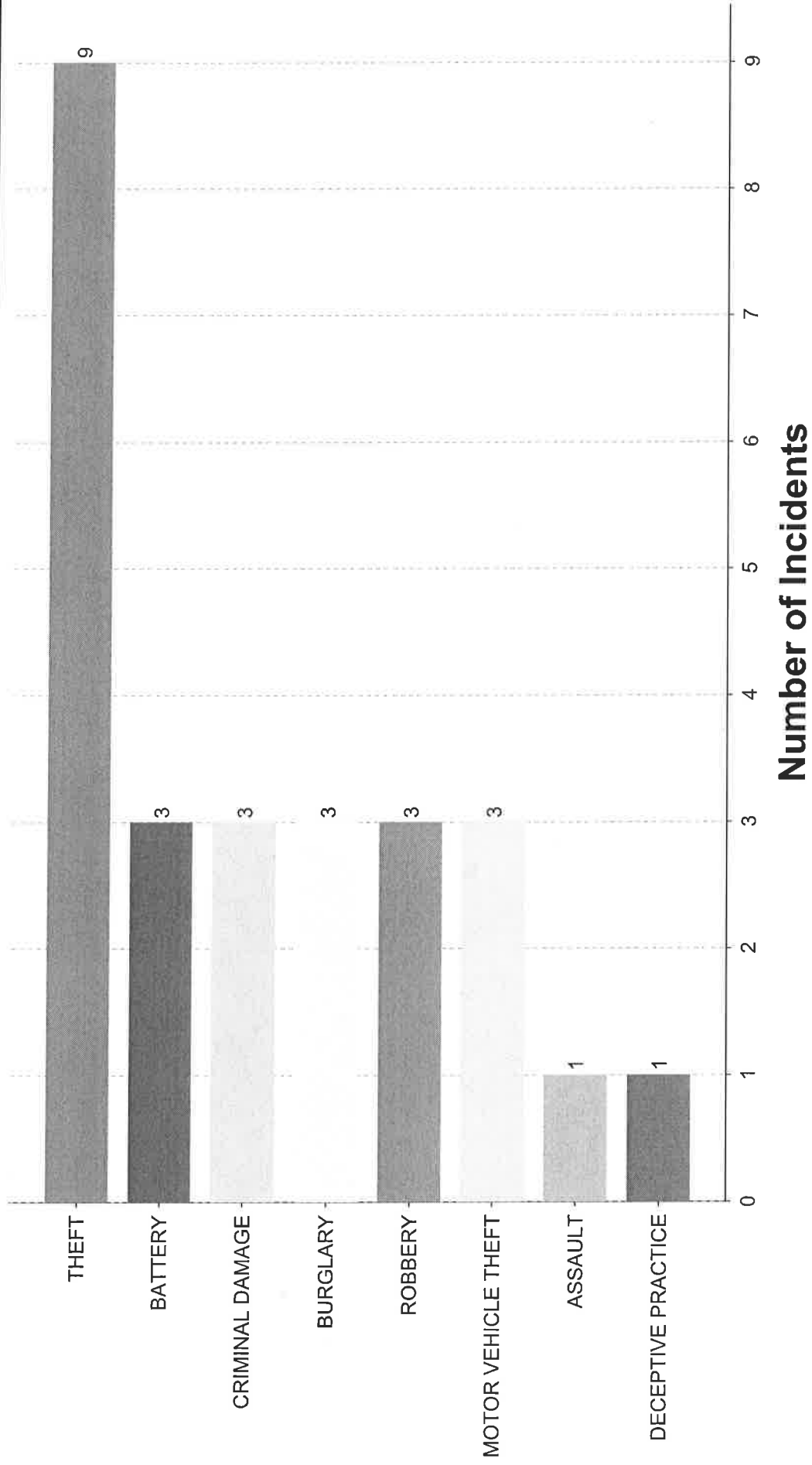

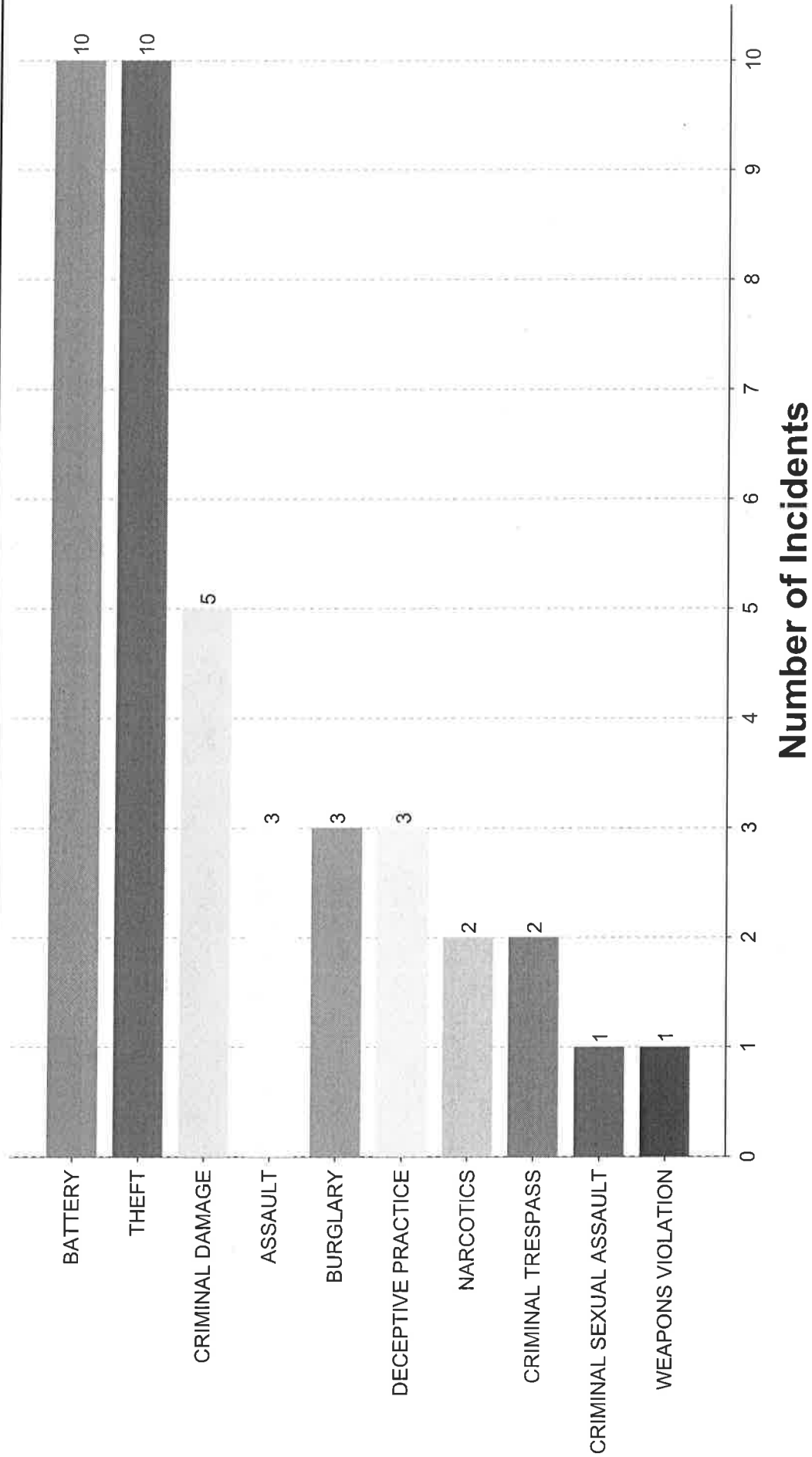

Commercial Armed Robberies 017th District (Albany Park)

About the Crime:

There have been two recent commercial armed robberies in the 17th District on Beat 1722. In both of these incidents, the offender entered the business, displayed a knife and demanded money from the cash register.

Incident times and locations:

- 4400 Block of North Elston Avenue on March 31, 2020 at 6:05 pm.
- 4400 Block of North Cicero Avenue on April 2, 2020 at 6:07 pm.

About the Offender:

Male White or Male White Hispanic, 16 to 25 years-old, 5'09 to 5'11, 140-160 pounds, wearing a face mask, gray hooded sweatshirt, hat

What you can do:

- Be aware of this crime and alert other Businesses.
- Business owners should ensure that their business equipped with a working video surveillance system and Burglar alarm.
- Call 911 immediately and provide a detailed description of the offender(s) including any vehicle description and license plate information as well as direction of flight, if known.
